A Notice is served hereby to the members of Professional Protection Scheme, G.S.B., I.M.A. for the re-newal of the membership for the year 2026-2027. **Before taking any action, please read the following instructions carefully.**

- (1) Attention of the members is drawn to the Clause No. 10 : of the Constitution, which reads as follows.
DISCONTINUATION - RENEWAL - REJOINING
 - (A) Notice will be sent one month in advance to all the members for renewal of the membership.
 - (B) A member who does not pay the Members Contribution in advance before 31st March (before the expiry of the indemnity cover) shall be discontinued without any notice.
 - (C) However, if a discontinued member wants to revive his/her membership within one month of the expiry of the indemnity cover, he/she pay Members Contribution only, but the indemnity covered shall be provided from the day of revival of the membership.
 - (D) After one month, if a member wants to rejoin the Scheme, he/she shall be treated as a new member and he/she shall have to pay Admission Fees as well as Members Contribution.
- (2) At the time of remittance, please present Completely filled up **Renewal Application Form**
- (3) (A) Pay by your Credit Card / Debit Card / Net Banking through our **Website www.ppsgsbima.com**. Payment through online transactions would NOT be charged anything extra, over and above Members Contribution.
- (B) Please draw "**A/c. Payees**" Cheques / Multi-City Cheque/Demand Draft in favour of "**P.P.S. G.S.B.,I.M.A.**" Payable at Ahmedabad only.

DUTIES OF THE MEMBER

- (A) Whenever a member gets legal notice for alleged negligence in management of his/ her patient, he/she has to contact our PPS office with a copy of complaint which he has received.

Following records must be sent with copy of notice.

- (1) Photocopies of outdoor / indoor case papers.
 - (2) Photocopies of investigation done & treatment given.
- (B) Avoid making any oral or written commitment without the specific permission of the Scheme.
- (C) Hand over all the original documents or Xerox copies demanded by the legal counsel & keep extra copies with him.
- (D) (i) If a member so desires, he/she can engage his/her own defense lawyer at his own cost, which shall not be reimbursed by the Scheme.
- (ii) Such a lawyer shall assist the panel lawyer in his defense in which case the decision of the panel lawyer will be final & binding.

OR

Arrange for his/her independent defense in which case any liabilities of the Scheme with regards to the risk & cost arising there of shall stand discharged and shall not be reimbursed.

- (E) If the member of PPS is also insured by any insurance company/ companies and if a complaint is filed against him/her, the PPS undertakes to offer him/her services of panel advocates for his/her defense. In that case, if he/she refuses to accept the offer and chooses to be defended by insurance company only, then PPS will not have any liability for outcome of the case.
- (F) The Scheme should be informed, and written consent/permission must be taken from scheme for compromise settlement/ Compensation/ or transfer of any case pending in the court to any other court including "Lok Adalat".
