The fast growing confidence of members of our association in the state office gives immense pleasure & satisfaction. I am satisfied by scientific programmes & community Health Programmes.

I am glad to inform you that I.M.A. of India has assigned

to work on RNTCP Project for which Gol and the Indian Medical Association (IMA) came together in partnership, under The Global Fund to address issues around public-private mix (PPM) in TB and launched the IMA GFATM RNTCP PPM project in 2007 in 5 states and 1 Union Territory (UT). IMA members who were private doctors were sensitized and trained on the management of TB under RNTCP. The project was extended to 15 states and 1 UT under Rolling Continuation Channel of GFATM through a memorandum of understanding (MoU) between Gol's Ministry of Health and Family Welfare (MoHFW) and IMA for 6 years (1st April 2009 to 31st March 2015). Gol is the primary recipient of GFATM funds, with IMA being the sub-recipient. Since its launch, the project has generated awareness and goodwill for the national TB program amongst the private medical fraternity. IMA so far has sensitized 87,292 and trained 15,022 private doctors; 4,359 DOT centers and 93 DMCs have been established.

In this context, Gol desires increased activity under the IMA project. IMA deems it a national duty and desires to enhance its public health contribution. Hence this midcourse addendum to the project has been proposed.

I whole heartedly congratulate **Dr. Jitendrabhai B. Patel** for being elected as National President (Elect) of Indian Medical Association for the year 2013-2014.

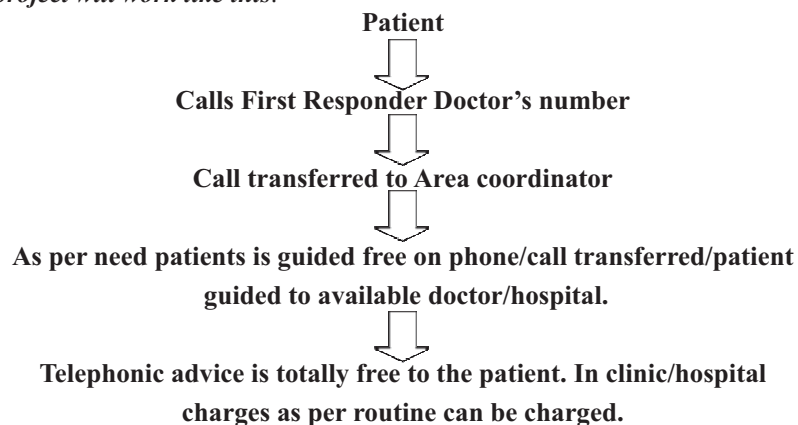


